QUALIFIED SIBLING TRANSPORTATION APPLICATION

Service Information:

- A current-year Qualified Sibling Transportation application must be submitted each school year for each student assigned service as a Qualified Sibling.
- Transportation to the assigned bus stop is the responsibility of the parent/guardian.
- It may take up to three weeks for a student's name to appear on the manifest. Qualified Sibling transportation will not be approved for the first 2 weeks of the school year.
- Transportation will notify the school of attendance via a Transported Student Form when service is approved.
- Transportation services for a Qualified Sibling are available only when the Qualified Rider rides the bus and when seating is available.

Payment Information:

- The annual fee for Qualified Sibling transportation service is \$500.
- Pro-rated fees will be based on the student's "Service Start Date" entered by the school official at the bottom of this form or if one-way service is requested and utilized.
- Payment is required at the time the application is approved to avoid interruption of service. Parents may use the semester payment option if desired. To avoid service interruption, the first payment is due at the time service is assigned and the 2nd semester payment is due no later than 01/31/23.
 Students approved for 2023-24 Free and Reduced Lunch (FRL) are not required to pay the transportation fee.
- Credit Card payments may be made on-line via <https://paypams.com>
- Checks/Money Orders must be made payable to SDUSD (or San Diego Unified School District) and mailed to the address at the top of this form. Checks returned for insufficient funds will cause a service interruption and a \$35 fee applied to the student account.
- Cash Payments may be made in person at the Transportation Department.
